

Ultimate Georgia Vacation Official Rules

NO PURCHASE NECESSARY. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING.

1. Eligibility: Ultimate Georgia Vacation (the "Sweepstakes") is open only to legal residents of the fifty (50) United States and the District of Columbia who are at least eighteen (18) years old at the time of entry. Employees of The Georgia Department of Economic Development, Engauge Marketing, LLC, ePrize, LLC, and their parent and affiliate companies as well as the immediate family (spouse, parents, siblings and children) and household members of each such employee are not eligible. Subject to all applicable federal, state, and local laws and regulations. Void where prohibited. Participation constitutes entrant's full and unconditional agreement to these Official Rules and Sponsor's and Administrator's decisions, which are final and binding in all matters related to the Sweepstakes. Winning a prize is contingent upon fulfilling all requirements set forth herein.

3. Timing: The Sweepstakes begins on July 1, 2010 at 12:00 a.m. Eastern Time ("ET") and ends on July 31, 2010 at 11:59 p.m. ET (the "Promotion Period").

Sponsor's computer is the official time-keeping device for the Sweepstakes.

4. How to Enter: During the Promotion Period, visit www.exploregeorgia.org and complete the registration page including full name, email address, and physical address. P.O. Boxes are prohibited. Then, use the Explore Georgia site database to select the different lodging, events, and attractions that would make up your ultimate Georgia vacation to receive one (1) entry into the Sweepstakes.

Multiple entrants are not permitted to share the same email address. Any attempt by any entrant to obtain entries by using multiple/different email addresses, identities, registrations and logins, or any other methods will void that entrant's entries and that entrant may be disqualified. Use of any automated system to participate is prohibited and will result in disqualification. In the event of a dispute as to any registration, the authorized account holder of the email address used to register will be deemed to be the registrant or player. The "authorized account holder" is the natural person assigned an email address by an Internet access provider, online service provider or other organization responsible for assigning email addresses for the domain associated with the submitted address. The potential winner may be required to show proof of being the authorized account holder.

5. Grand Prize Drawing: Administrator is an independent judging organization whose decisions as to the administration and operation of the Sweepstakes and the selection of the potential winner are final and binding in all matters related to the Sweepstakes. Administrator will randomly select the potential Sweepstakes winner from all eligible entries received during the Promotion Period, on or around August 11, 2010. The potential winner will be notified by mail, email or phone. The potential winner (parent/legal guardian if winner is a minor in his/her state of residence) will be required to sign and return an Affidavit of Eligibility, Liability & Publicity Release ("Affidavit"), which must be received by Administrator within ten (10) days of the date notice or attempted notice is sent, in order to claim his/her prize. If the potential winner cannot be contacted, fails to execute and return

the Affidavit within the required time period, does not comply with these Official Rules, or prize is returned as undeliverable, potential winner forfeits the prize. Package includes two (2) nights' accommodations at the Lake House at Legacy in Lake Lanier Islands (single room, quad occupancy); two (2) mornings of buffet breakfast for four (4) in the Windows Restaurant at Lake Lanier to be redeemed during the Lake Lanier stay; dinner (excluding alcohol) for four (4) at BullFrogs Restaurant OR Sunset Cove Restaurant in Lake Lanier to be redeemed during the Lake Lanier stay; winner's choice of any two (2) of the following Lake Lanier activities to be redeemed during Lake Lanier stay: four (4) Lake Lanier Islands Waterpark tickets, a half-day boat rental, horseback riding for four (4), OR golf for four (4) (specific times, locations, and length of events determined by Sponsor in its sole discretion); two (2) nights' accommodations at Cuscowilla Resort on Lake Oconee (single room, quad occupancy); two (2) mornings of breakfast for four (4) in the Golf House Grill at Cuscowilla Resort to be redeemed during the Lake Oconee stay; dinner for four (4) at Waterside Restaurant OR Golf House Grill at Cuscowilla Resort to be redeemed during the Lake Oconee stay; a round of golf for two (2) at Cuscowilla Resort to be redeemed during the Lake Oconee stay; two (2) nights' accommodations at the Westin Resort Savannah Harbor in Savannah (single room, quad occupancy); tickets for four (4) on the Historic Savannah Trolley Tour; a digital video camera (brand, make, and model determined by Sponsor in its sole discretion); a \$300 gas gift card (specific brand of card determined by Sponsor in its sole discretion; terms and conditions of card apply); and vouchers for ice cream (specific value and number of vouchers determined by Sponsor in its sole discretion). Winner must complete the package by December 31, 2010 or prize will be forfeited. Package must be taken in a single time frame and all prize elements must be redeemed as part of this time frame. After time frame has concluded any remaining unused package elements will be forfeited in their entirety. Hotel and package elements must be booked at least twenty-one (21) days prior to departure. Travel companion must execute liability/publicity releases prior to issuance of travel documents. Restrictions, conditions and limitations may apply. 7. Sponsor reserves the right, in its sole discretion, to disqualify any individual it finds to be tampering with the entry process or the operation of the Sweepstakes or to be acting in violation of these Official Rules or any other promotion or in an unsportsmanlike or disruptive manner. Any attempt by any person to deliberately undermine the legitimate operation of the Sweepstakes may be a violation of criminal and civil law, and, should such an attempt be made, Sponsor reserves the right to seek damages from any such person to the fullest extent permitted by law. Sponsor's failure to enforce any term of these Official Rules shall not constitute a waiver of that provision.

If for any reason an entrant's entry is confirmed to have been erroneously deleted, lost, or otherwise destroyed or corrupted, entrant's sole remedy is another entry in the Sweepstakes, provided that if it is not possible to award another entry due to discontinuance of the Sweepstakes, or any part of it, for any reason, Sponsor, in its sole discretion, may elect to hold a random drawing from among all eligible entries received up to the date of discontinuance for any or all of the prizes offered herein. In the event that production, technical, seeding, programming or any other reasons cause more than the stated number of prizes as set forth in these Official Rules to be available and/or claimed, Sponsor reserves the right to award only the stated number of prizes by a random drawing among all legitimate, un-awarded, eligible prize claims.

Disputes: Except where prohibited, entrant agrees that: (1) any and all disputes, claims and causes of action arising out of or connected with this Sweepstakes or any prize awarded shall be resolved individually, without resort to any form of class action, and exclusively by the United States District Court for the Eastern District of Michigan (Southern Division) or the appropriate Michigan State Court located in Oakland County, Michigan; (2) any and all claims, judgments and awards shall be limited to actual out-of-pocket costs incurred, including costs associated with entering this Sweepstakes, but in no event attorneys' fees; and (3) under no circumstances will entrant be permitted to obtain awards for, and entrant hereby waives all rights to claim, indirect, punitive, incidental and consequential damages and any other damages, other than for actual out-of-pocket expenses, and any and all rights to have damages multiplied or otherwise increased. All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, or the rights and obligations of the entrant and Sponsor in connection with the Sweepstakes, shall be governed by, and construed in accordance with, the laws of the State of Michigan without giving effect to any choice of law or conflict of law rules (whether of the State of Michigan or any other jurisdiction), which would cause the application of the laws of any jurisdiction other than the State of Michigan.
